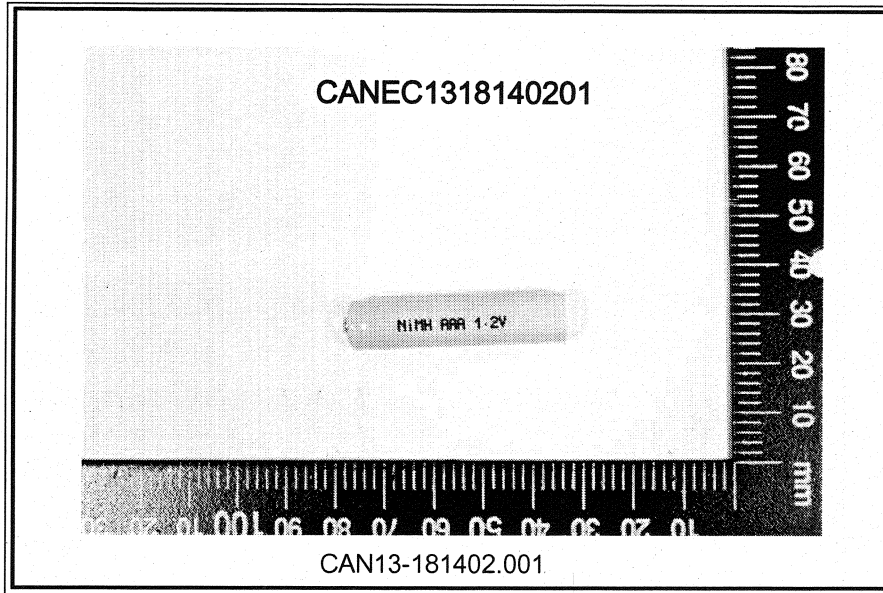
Battery Testing Flow Chart
